TRANSFER OF OWNERSHIP FOR HORSES REGISTERED WITH AHAA

Application for a transfer of ownership will only be accepted from financial members of the Association. Owners of entires or mares must be Full members while gelding owners may have Associate membership. The transfer needs to be completed within 90 days of acquisition or a late fee will apply.

PROCEDURE

1. The vendor must complete the appropriate section of the AHAA Certificate of Registration. This includes Name, Address, Date of Transfer and Signature.
2. The Purchaser must complete the appropriate section immediately below the Vendor section. This includes Name, Address, Date of Transfer and Signature and Date of Signing.
3. The Purchaser should forward the completed Certificate of Registration, Transfer form and payment to the AHAA Secretary within 90 days of acquisition. After processing, the Certificate of Registration will be returned to the Purchaser.
4. Cheque or money order fee payment may accompany the Certificate or payment may be made by bank transfer (details below).

IMPORTANT ADVICE RE SALE

It is the vendor's obligation to present the AHAA Registration papers to enable the purchaser to compare markings, brands and other identification with the horse presented for sale.

It is the purchaser's obligation to inspect the AHAA Registration papers and compare markings, brands and other identification with the horse presented for sale.

FORWARDING OF FORM & FEE

The original completed Certificate of Registration, this Transfer Form and the Transfer Fee must be forwarded within 90 days of acquisition to:

FEE

The transfer fee is \$50 if received within 90 days of acquisition or \$80 if received after ninety (90) days. Payment can be made by direct deposit, cheque or money order.
